The application is for the renewal of the existing permission for seven temporary fenced exclosures on the commons which was granted in 2008.

The exclosures are to protect five areas of woodland planted in 2009, an area of rare high altitude oak woodland and a stand of juniper scrub from sheep grazing.

Natural England consider that further time is required to allow the woodland to become established and capable of withstanding sheep grazing once the fences are removed. Further details can be found in Natural England's 2023 review of the scheme and Northern Habitats 2023 assessment of the progress of the woodland exclosures which accompany this application.

There will be a series of pedestrian gates and stiles to allow the public to access the fell either side of the fences. All gates and stiles will be compliant with BS5709.

To achieve the SSSI and SAC conservation objectives the fencing will continue to exclude livestock from grazing one of two remaining areas of rare juniper scrub. The slow growing young and pioneer juniper plants are specifically targeted by browsing sheep which prevents recruitment of young plants to stands of juniper subject to sheep grazing bringing the long term survival of juniper stands on the common in to question.

In the absence of fencing there was little evidence of natural regeneration of oak and other trees in Young Wood, which is the highest oak wood in the UK. Since the wood has been fenced oak saplings have become established within the enclosure. Continuing to excluded sheep from the wood will allow further recruitment of young trees toto the woodland and help to expand the extent of the woodland. The saplings which have appeared during the first period of exclosure will benefit from a further 15 years of growth making them more resistant to sheep grazing once the fence is removed. The presence of young trees in the woodland is essential for the wood to meet the SSSI and SAC conservation objectives.

The objective of the fencing around the five areas of new woodland planting is to protect the young trees from grazing and allow them to grow to a size where they will be resistant to sheep grazing once the fences are removed. Due to the climate and poor soils on the commons trees are slow growing and inspection of the trees by Northern Habitat and Natural England in 2023 has confirmed that protection from grazing for a further 15 years is required to ensure the success of the woodland creation scheme in the long term. There is a significant risk that if the fencing were to be removed now there would be significant loss of the planted trees such that little benefit would be seen to have resulted from the 15 years of reduced access to these areas and the input of public funds to this project.

The stock reductions are currently in place on the commons as part of a Countryside Stewardship Scheme. These benefit heathland and mire communities but not the upland woodland and juniper scrub vegetation. To reduce grazing levels to such an extent that woodland and scrub habitats would benefit would prove to be very expensive to the public purse and would threaten the continuation of the common land grazing system of these commons. This grazing system is one of the defining features of the English Lake District World Heritage Site and loss of this system on an area as large as these commons would constitute a significant detrimental impact on the World Heritage Site. The use of relatively small fenced exclosures is considered to achieve a balance between agricultural and world heritage objectives on one hand and ecological objectives on the other.

No Fence GPS collars have been considered as an alternative to fencing, however it is not currently financially viable to use these for sheep on upland commons as the numbers of collars required is very large (1,000+ in this case), with each collar having both a purchase cost and an annual subscription cost which amounts to tens of thousands of pounds for a flock. It is also not certain that the collars will work with hill breeds of sheep due to the thick fleece.

The proposal is predicted to have a positive impact on the condition of the woodland and juniper scrub interest features of both the SSSI and SAC. The proposals are also likely to have a positive impact on water quality in the River Derwent and Tributaries SSSI and River Derwent and Bassenthwaite SAC as the Rivers Glenderamackin and Glenderaterra drain the fells on which the exclosures are located and are tributaries of the River Derwent.
